This screen is warranted by Vista One Inc. solely to the purchaser of the product to be free of manufacturers' defects in materials or workmanship, solely to the original purchaser residing at the residence where the screen was initially installed by an authorized Vista One technician and that the product remains at its original point of installation. Vista One Inc. will repair or replace at its discretion any component, within the terms and conditions of this warranty, which is deemed as having defects from the manufacturing process upon proof of purchase. The word "defects", "defective" as stated in this warranty, is defined as imperfections that hinder the utility of the product.

This warranty is specifically limited to components, excluding the screen mesh and the integral tension wires of the mesh (if applicable). This warranty does not cover components damaged through improper use or maintenance, or if components have been altered from their original state. This non-transferable, limited warranty excludes breakage or damage due to normal wear and tear, lack of maintenance, or use of other than residential applications, accidents and "acts of god".

If a component is deemed defective within the terms of the warranty, Vista One Inc. will, at its discretion, replace or repair the component at no cost. Labor is only included for a period of one year from the date of purchase and/or installation, after which time charges will apply. The paint or otherwise powdercoat finish is warranted for one year against chipping and fading.

Replacements or repairs made subject to this limited lifetime warranty are otherwise warranted for the balance of the original warranty period.

Vista One Inc. liability under this limited lifetime warranty is restricted to the corrective actions as set forth herein and contrarily repudiates all incidental and consequential damage.

This screen is designed to assist in keeping unwanted insects from the home; it is in no way intended as a safety or security device to prevent access or exit by individuals, animals or small children. Liability for any damages, including but not limited to general, special, indirect, incidental, consequential, aggravated, punitive or exemplary damages, and economic loss, as well as for breach of any expressed or implied warranties, including but not limited to implied warranties of merchantability, quality and fitness for any purpose other than as prescribed herein, is disavowed and omitted here from, to the extent that such a disclaimer and preclusions are permitted by the laws of any particular jurisdiction.

- B). Improperly operating or handling of the screen.
- C). Unauthorized repairs, alterations, modifications and/or installations made or attempted by individuals who are not affiliated with Vista One Inc.
- D). Accidents, misuse or abuse of the screen and/or "Acts of God".
- E). Use of the product in commercial applications.
- F). That the screen is installed at the original address and location that the authorized Vista One Inc. professional installer installed it originally. Component defects should be reported to the original installer, who will carry out the warranty work on behalf of Vista One Inc.
- G) Asserted defects involving subjective personal likes or judgments.
- H) Defects asserted by any purchaser who did not purchase the screen from an Authorized Vista One Inc. Distributor or dealer in Canada or the United States of America.

In no event shall Vista One Inc. be liable for damages of any type, including, but not limited to: economic loss; or any indirect, punitive, special, incidental, or consequential damages of any type, including, but not limited to, time, wages or lost profits, of any nature or kind or for damages to or loss of property, whether caused by negligence or otherwise.

Any implied warranty, including, but not limited to, the implied warranty of Merchantability and the implied warranty of fitness for a particular purpose, is hereby limited in duration to that of the express limited warranty contained in this document, unless a shorter period is permitted by law. This document sets forth the entire liability of Vista One Inc.
